We provide ESG data for close to 16,000 companies (active, inactive and private) including many of the primary, global and some regional indices like MSCI World, MSCI Europe, STOXX 600, NASDAQ 100, Russell 3000, S&P 500, FTSE 100, ASX 300 and MSCI Emerging Market. In addition, we offer takeover defence profiles on 10,000+ public companies with nearly 12,000 Poison Pill "Events". We have an in-depth coverage across 870+ ESG data points and 100+ ESG analytics back to 2002.
