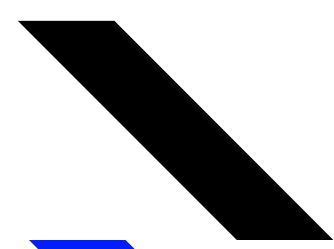

1 Introduction

This document provides details of the Point in time (PIT) bulk service that is provided to the Environmental, Social and Governance (ESG) bulk delivery capability.

This service provides the ESG Measures data with Point in time history for each of the companies in the ESG universe.

In order to concord ESG content with the customer entity master and with other Refinitiv content sets, entity symbology and reference content, this document should be used in conjunction with the [Refinitiv Data Platform ESG Symbology User Guide](#).

2 About the files

Each week updates to the Environmental, Social and Governance (ESG) Point in time data are delivered to Refinitiv Data Platform (RDP). Refinitiv Bulk files are distributed in csv format, with the file extension .csv.

Two types of data updates are available.

- A full set of csv data files containing all history for all data items and all organizations.
- A delta csv data file that contains only incremental changes to the universe since last week.

Full Initialization Files

One zip file is created containing all organizations for one year of history. Both active and inactive organizations are included in the data file. Each zip file contains a separate csv file for each organization

Delta Files

An incremental update is generated for each value that has changed since last week. The incremental update will contain only the values for an organization and period that have changed. Each zip file contains a single csv file containing all created/modified or deleted data for all organizations.

ESG PIT Files are published each Monday by 9am UTC.

The ESG csv files are zipped and delivered as .zip files. The following naming convention is used for the .zip files:

File Types

There are 5 different types of files supporting 5 different types of dataitem. A glossary for ESG Point in time values is available in My Refinitiv. This glossary details which items are included within each file, and how far back the point in time history can be populated for each item. Fiscal history is available for each of these files since 2002.

Year

Initialization/Full files are partitioned by fiscal year, all companies for that fiscal year are included in the zip file. Delta/incremental files do not use the fiscal year partition.

UpdateType

There are two update types

Code	Description	Notes
F	Initialization	Full initialization file of all data for all organizations
I	Delta incremental	Delta files contain only the items that changed within the past week.

Date

The date the file starts the generation process in the format yyyy-mm-dd-hhmm.

The following examples illustrate the naming convention

EsgPITAnalyticValueScore.2017.F.2023-06-26-0611

An ESG full initialization file containing Scores for indicators that contribute towards the ESG , for all companies for the 2017 period. The file generation began on 26th June 2023.

EsgPITValues.I.2023-06-19-0407

An ESG delta file containing all the datapoints that changed in the past week, for all companies and all periods. The file generation began on 19th June 2023.

Files will remain accessible for 2 weeks before being removed. The zipped files can be uncompressed using standard tools such as 7-zip

3 How to access the files

File Distribution, also known as Client File Store (CFS), is a service of the Refinitiv Data Platform (RDP) that aids in the discovery and delivery of files to subscribers via web-based REST APIs. Refinitiv publish bulk ESG files to the File Store.

The ESG PIT data is delivered through 1 fileset using the following package and fileset name.

Subscribers will be able to see all files, but only permitted to download the ESG PIT files if they have an active subscription.

4 About the Content

4.1 Overview

An OrganizationId uniquely identifies each organization. These identifiers are generated and maintained by Refinitiv. They do not change over time and are never re-used.

OrganizationId will be impacted by certain events such as mergers, acquisitions.

A merger or acquisition that involves two entities and causes a new entity to be created. Both existing OrganizationId's are considered inactive, and the new entity is given its own unique OrganizationId.

One original entity survives as the new, merged entity, will retain the original OrganizationId.

Organization changes status from public to private, the OrganizationId can change, all history will be copied over onto the new OrganizationId..

The Environmental, Social and Governance (ESG) service includes all Organizations which have Refinitiv ESG content available.

4.2 ESG Coverage

The point in time files contain all data points, indicators and scores, as detailed in the Refinitiv ESG Point in Time Glossary, published in [MyRefinitiv](#).

Not all ESG datapoints are available in the point in time files, the details of those available are identified in the glossary.

4.3 Anti-Takeover Devices (ATD) Coverage

Organizations flagged as being part of the ATD population are limited to updates in the following fields. Due to the limited nature of these fields you may choose to exclude ATD Organizations from your processes.

Full details pertaining to these fields can be found in the Refinitiv ESG Glossary.

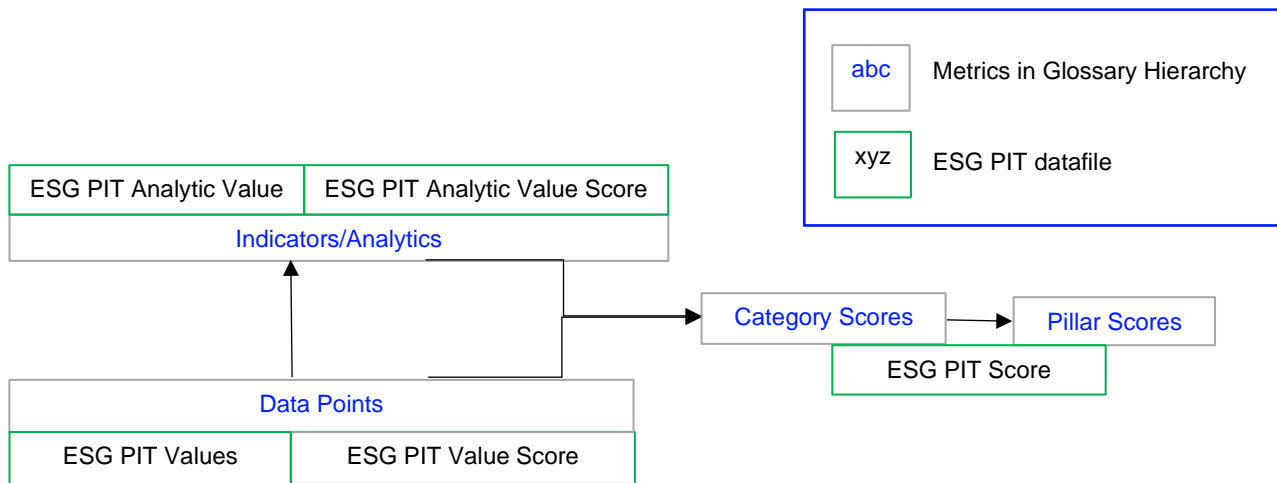


